## 236<sup>th</sup> ST NE CORRIDOR IMPROVEMENT PROJECT-PHASE 1

The improvement(s) for which Project Proposals will be received is described below:

This project provides for the improvement of 236<sup>th</sup> St from 13<sup>th</sup> Ave NE to east of 19<sup>th</sup> Ave NE. The project will widen approximately 2,800 linear feet of existing roadway to accommodate a two-way left-turn lane, shared-use path, and new roundabout located at the intersection of 19<sup>th</sup> Ave. Altogether the proposed improvements include clearing and grubbing, temporary erosion control, roadway excavation and embankment, stormwater conveyance, utility conduit installation, concrete curb and gutter, curb ramps, illumination, asphalt paving, guardrail, precast concrete barrier, traffic control, permanent fencing, pavement markings, planting, hydroseeding, permanent signing and all other work in accordance with the attached Contract Plans, these Contract Provisions, and the Standard Specifications.
